



Articulation Agreement

Between

BAKHTAR University

Opposite of MoHE, Kart a 4, Kabul, Afghanistan

And

National Institute of Management and Administration (NIMA)

Sanatorium Street, Darul Aman Road, Kabul, Afghanistan

Terms:

This agreement defines the terms agreed to by the two parties regarding the transfer and degree completion at BAKHTAR of NIMA students having earned the Associate Degree of Applied Science in accounting, management or ICT at NIMA and wishing to pursue their studies at BAKHTAR in order to obtain the Bachelor degree in Business Administration or Computer Science. They will be following a three to three and a half year program at BAKHTAR based on the number of credits completed at NIMA and the detailed calculation made by both the parties.

Responsibilities of BAKHTAR:

BAKHTAR will admit NIMA students to pursue their studies in order to obtain, after two years of study at BAKHTAR, the Bachelor degree in Business Administration or Computer Science. The tie-up here is totally based upon these following regulations both will follow:

1. NIMA graduates of Management, Accounting and ICT, with 80% or higher cumulative percentage at end of their associate degree will be enrolled in 3rd semester of Bachelor of Business Administration (BBA) and Bachelor of Science in Computer Science program of BAKHTAR University.
2. NIMA graduates of Management, Accounting and ICT departments with lower than 80% cumulative percentage at the end of their associate degree will be enrolled in 2nd semester of Bachelor of Business Administration (BBA) and Bachelor of Science in Computer Science program of BAKHTAR University.

3. In all cases, students will be subject to BAKHTAR's rules and regulations during the entire period of their studies at BAKHTAR.
4. Transferred students will be entitled to a scholarship representing 40% of the BAKHTAR's monthly tuition fee which is to be paid as per the tri-monthly basis. The 45% scholarship will be applied during the course studies at Bakhtar Univesity.
5. BAKHTAR will provide the three 1st position holders 100% discount, the three 2nd position holders 75% discount and the three third position holders discount in the 3rd semester only. The discount will only remain if students performs well in the 3rd and upcoming semesters of Bakhtar bachelor programs.
6. Both parties will get involved in Faculty Exchange for short and long terms if need be and the compensation and other terms will be decided mutually.
7. BAKHTAR will invite NIMA to participate in events (i.e. career/job fair, environment day, women's day, public private sector partnerships, guest lectures etc.) organized by BAKHTAR.

Responsibilities of NIMA:

1. NIMA will provide opportunity to BAKHTAR for facilitation of the BAKHTAR programs and student recruitment.
2. NIMA will verify course completion of NIMA students & will send the list and transcripts to BAKHTAR after arranging a PPT presentation with all pass outs of NIMA regarding Bakhtar
3. NIMA will invite BAKHTAR to participate in events (i.e. career/job fair, environment day, women's day, public private sector partnerships, guest lectures etc.) organized by NIMA.
4. NIMA student clubs (i.e. sports, management, accounting, women association, English, debate, newsletter) will connect with student clubs at BAKHTAR.
5. NIMA will allow BAKHTAR's teachers and students to use their playing grounds, library, and other infrastructural facilities and Bakhtar will also do the same. The facilities of both institutions can be made available for students and teachers based on prior and mutual agreement.

This agreement is applicable for every student of NIMA. This agreement may be modified by the mutual written consent of both parties. Either party may terminate this agreement by giving notice six months in advance to the other party. Such termination will not affect the participation in the program of those NIMA students who will be in BAKHTAR.


